

A BYLAW OF THE VILLAGE OF PELLY AUTHORIZING
COUNCIL OF THE SAID VILLAGE TO ENTER INTO A
PUBLIC RENTAL HOUSING AGREEMENT.

WHEREAS provision is made in the Saskatchewan Housing Corporation Act, R.S.S. 1978, CH.S-24, enabling the Council of Any Municipality subject to the approval of the Local Government Board, to enter into a Public Nonprofit Housing Partnership Agreement or Agreements as contemplated by Section 26 of the said Act, and
WHEREAS the Council of the Village of Pelly deems it expedient to undertake a Public Nonprofit Housing project within the terms of the said Act:

NOW THEREFORE the Council of the Village of Pelly enacts as follows:

(1) That the proposed Agreement hereunto annexed and marked as Schedule "A" to the Bylaw and which is deemed to be part of this Bylaw, being an Agreement between:

THE SASKATCHEWAN HOUSING CORPORATION

(Hereinafter called "the Provincial Corporation")

OF THE FIRST PART:

THE VILLAGE OF PELLY

OF THE SECOND PART:

be and the same is hereby ratified and confirmed.

(2) That the Mayor and Clerk for the Village of Pelly be and they are hereby authorized and empowered to sign the said Agreements on behalf of the said Village and affix thereto the corporation seal of the Village.

(3) That this Bylaw shall come into force on the date of final passing thereof.
