

BYLAW NO. 2-2005

BYLAW OF THE VILLAGE OF PELLY TO ESTABLISH AND REGULATE A
WASTE DISPOSAL SITE.

The council of the Village of Pelly, in the Province of Saskatchewan, enacts as follows:

1. Definitions:

- (a) "garbage" means putrescible animal and vegetable remains and byproducts resulting from handling, preparation, cooking and consumption of food;
- (b) "putrescible" means capable of becoming putrid;
- (c) "liquid animal waste" means any waste which contains animal, mineral or vegetable matter in solution or suspension.;
- (d) "refuse" means putrescible and nonputrescible remains, byproducts, and discarded materials resulting from domestic, commercial, industrial, or agricultural activities and includes garbage, rubbish, street cleanings and yard clippings, but excludes liquid human waste, human excrement, and dead animals;
- (e) "bulk refuse" means wood, trees, shrubs, stumps and branches;
- (f) "rubbish" means nonputrescible remains and byproducts, consisting of both combustible and noncombustible remains and byproducts, and includes tin cans, wood, glass, bedding and crockery;
- (g) "whites" means large metallic objects such as major appliances, water heaters, stoves, furnaces, washers, dryers, refrigerators, deep freezers, dishwashers, bed springs, fencing gates;
- (h) "sharps" means needles.
- (i) "waste disposal site" means the site located within SW 3-34-32-W1, in the Province of Saskatchewan, which is surrounded by a fence and contains within the fence one or more trenches for holding waste;
- (j) "designated areas" means separate areas within the waste disposal site that are set aside for the disposal of particular kinds of waste, which areas are identified either by signs or by a Village representative;
- (k) "dispose" means to place by any means or otherwise get rid of;
- (l) "public highway" means road allowance, road, street, or lane vested in Her Majesty or set aside for such purpose and includes the entry road to the waste disposal site, a bridge, culvert, drain, or public improvement erected upon or in connection with such a public roadway.


- 2. All garbage, refuse, bulk refuse, rubbish, and whites shall be disposed of in designated areas of the waste disposal site.
- 3. No person shall dispose of any garbage, refuse, bulk refuse, rubbish, whites, or any other waste material, at the gate or on the roadway or road right-of-way leading to the waste disposal site.
- 4. No person shall, at the waste disposal site, dispose of:
 - (a) Manure, grain, petroleum wastes, slaughter house wastes, dead animals, and other comparable wastes,
 - (b) Liquid manure wastes,
 - (c) Automobiles, trucks, machinery, tires or batteries.
 - (d) Concrete, concrete products, rocks and soils contaminated with cement products,
 - (e) Pesticide and chemical containers
 - (f) Recyclable paper and cardboard
 - (g) Computers
 - (h) Sharpsunless written permission is obtained in advance from the Village council and such permission is in accordance with the terms and conditions set by Saskatchewan Environment and Public Safety.

5. Permission to use the waste disposal site
No person, whether individual or corporate, shall place, dump, or dispose of any garbage, refuse, bulk refuse, rubbish, or whites at the waste disposal site without the written approval of the Village Council or the Village's authorized representative, pursuant to Section 6.
6. Use of the waste disposal site shall be restricted to residents of the Village of Pelly and to the municipalities which have a written agreement with the Village of Pelly.
7. For a pre-established annual fee, a municipality may be allowed to use the waste disposal site. The pre-established fee shall be determined by the operating costs of the waste disposal site.
8. The Village shall own and have the sole right to dispose of all refuse and other materials deposited at the waste disposal site. No person shall remove, disturb, or take away any material, object, or thing from the waste disposal site without written permission from the Village Council.
9. No person shall operate any vehicle transporting garbage, refuse, or rubbish over any public highway, unless the load is enclosed or covered or secured in a manner that is adequate to prevent littering.
10. Absolutely no burning is allowed at the waste disposal site unless it is authorized by the Village council or its representative and such burning is conducted according to the prescribed regulation by Saskatchewan Environment.
11. Signs shall be erected stating the rules of operation and the positions of the designated areas.
12. No person shall deface, destroy, or alter any signs, gates, or fencing at the waste disposal site.
13. Any person contravening any provision of this Bylaw is guilty of an offence and is liable upon summary conviction to a fine of not less than \$500.00 and not more than \$1000.00, plus costs.
14. If any person fails, neglects, or refuses to do anything that he/she is required to do by this Bylaw, such thing may be done by the Village Council at the expense of the person in default, and the Village may recover the expense thereof, with the costs, in the court of competent jurisdiction or in like manner as municipal taxes.
15. No part of this Bylaw shall be construed in a manner contradictory to the minimal requirement that Saskatchewan Environment and Resource Management from time to time establishes for operating the waste disposal site.
16. This Bylaw repeals Bylaw No. 4-92.
