A BYLAW TO PROVIDE FOR ENTERING INTO AN AGREEMENT FOR THE PURPOSE OF SHARING A WASTE DISPOSAL SITE.

The council of the Village of Pelly, in the province of Saskatchewan, enacts as follows:


The Village of Pelly is hereby authorized to enter into an agreement attached hereto and forming part of this Bylaw and identified as "Exhibit A", with the following municipalities:


Rural Municipality of St. Philips No. 301  
and  
Rural Municipality of Livingston No. 331

This agreement shall come into effect on January 1, 2006.

This Bylaw repeals Bylaw No. 1-97.



Exhibit A

WASTE DISPOSAL AGREEMENT

THIS AGREEMENT made this 12<sup>th</sup> day of December, 2005

BETWEEN

VILLAGE OF PELLY

and

RURAL MUNICIPALITY OF LIVINGSTON NO. 331

and

RURAL MUNICIPALITY OF ST PHILIPS NO. 301

THIS AGREEMENT WITNESSETH that in consideration of the mutual covenants and agreements hereinafter contained, each of the parties agrees with the other as follows:

1. The Village of Pelly grants to the Rural Municipality of Livingston No. 331 and the Rural Municipality of St. Philips No. 301, the right to use the waste disposal site located within SW 3-34-32 W1 in the province of Saskatchewan, to dispose of refuse in accordance and subject to Bylaw No. 2-2005.
2. The waste disposal site is to be regulated by the Village of Pelly's Bylaw No. 2-2005.
3. The fee charged to the Rural Municipality of Livingston No. 331 shall be twenty-five percent (25%) of actual costs of the waste disposal site from the preceding year.
4. The fee charged to the Rural Municipality of St. Philips No. 301 shall be twenty-five percent (25%) of the actual costs of the waste disposal site from the preceding year.
5. This agreement replaces the agreement signed on January 15, 1997, and shall come into effect upon the adoption of Bylaw No. 3-2005 by the Village of Pelly. This agreement shall be in effect until such time as it is replaced with another agreement by the unanimous consent and agreement of the parties thereto. This agreement may be terminated by any party to the agreement by giving one year notice of intent in writing.
