

BYLAW NO. 2017-07

A BYLAW TO PROVIDE FOR ENTERING INTO A TAX EXEMPTION AGREEMENT FOR THE PURPOSES OF ECONOMIC DEVELOPMENT

The Council of the Village of Pelly in the Province of Saskatchewan enacts as follows:

- 1. The Village of Pelly is hereby authorized to enter into an agreement, attached hereto and forming a part of this bylaw, and identified as "Exhibit A", with Fort Pelly-Livingstone Museum, assessed owner of 401 3rd Ave. S. legally described as Lot 10, Block 8, Plan 101710325 ext 3 to exempt said property from taxation and water, sewer and garbage utilities fees for the purpose of economic development.
- 2. The Mayor and the Administrator of Village of Pelly are hereby authorized to sign and execute the attached agreement identified as "Exhibit A".
- 3. Bylaw No. 6-2016 is hereby repealed.

WITNESSETH THAT **Fort Pelly-Livingstone Museum** is the owner of the land and/or improvements as follows: <u>401</u> 3rd Ave. S. legally described as <u>Lot 10</u>, <u>Block 8</u>, <u>Plan 101710325</u> ext 3:

IT IS AGREED THAT:

- 1. The taxable assessment of said property shall be exempt from taxation for the years **2017** to **2020** inclusive.
- 2. The fees for all utilities, water, sewer and garbage, shall be waived for the years **2017** to **2020** inclusive.
- 3. The owner hereby agrees to operate the Fort Pelly-Livingstone Museum, a public museum, from the said premises.
- 4. This agreement shall be terminated upon the sale of the subject property by the owner.
- 5. It is agreed that this written instrument embodies the entire Agreement of the parties hereto with regard to matters dealt with herein and that no understanding or agreements, verbal or otherwise, exist between the parties except as herein expressly set out.
